Appointment of Directors of Befriending Networks Ltd.

Befriending Networks Ltd is governed by a membership-led board of directors. The board can comprise of up to 10 directors, 6 as member directors, and 4 as appointed directors. The maximum term any director can serve is 5 consecutive years.

At each annual general meeting, member directors appointed by the board in the period since the last AGM must resign from office, alongside half of the remaining member directors. Those eligible may stand for re-election.

All appointed directors must resign at the AGM. Immediately after the AGM the board of directors may re-appoint or appoint directors to serve the board until the next AGM.

Member Directors – Election

The following individuals will resign from the board of directors, under clauses 59 and 61(a) of the articles of association.

- Rita Chadha – Member: Tower Hamlets Friends and Neighbours
- Julia Weir – Member: Jewish Care

Both are eligible and seek election to the board of directors by the membership.
